Sub: Solid Waste Management Rules – Notification No. S.O. 388 (E) by MoEF dt. 27.1.2026 – Proposal by Hyderabad Integrated MSW Ltd for collection of Industrial MSW Wastes.

We wish to bring to the notice of members that as per the recent Notification issued by MoEF on Solid Waste Management Rules, all solid MSW wastes generated in urban areas have to be collected, treated and disposed as per the rules stated in the notification. These rules will come into force with effect from 1.4.2026. Copy of the notification is enclosed for reference.

As Hyderabad Integrated MSW Ltd has been authorised by GHMC to collect all industrial MSW wastes vide GHMC letter dated 26.9.2022 (copy enclosed), they have approached BDMAI offering their services to collect the industrial wastes generated by member companies.

BDMAI further negotiated the rates and certain terms, which are given below:

- a) Registration of entity charges of Rs.25,000/- has been waived off.
- b) Frequency of collection is on daily or once in two days, depending upon volume of waste generated
- c) If required, Collection Bins may be arranged on hire basis
- d) They also offer their services to collect Plastic Drums etc., at an agreed rates. However, if the members want to dispose of them on their own, Hyderabad Integrated MSW Ltd will not interfere.
- e) Rates for collecting the Industrial MSW wastes and other terms are as per the proposal submitted by Hyderabad Integrated MSW Ltd, copy of which is enclosed.
- f) In case the units outside the GHMC limits wish to utilize HIMSW Ltd services, additional transportation charges may be applicable, as per agreed terms between HIMSW company and our members.

Since compliance of above Rules is mandatory and all are required to submit periodical reports to CPCB, a representative of Hyderabad Integrated MSW Ltd will be contacting you soon for completing Registration and other formalities.
