O R D E R:

In exercise of the powers conferred under sub-sections (1) and (2) of Section 4 of the Water (Prevention and Control of Pollution) Act, 1974, orders were issued in the G.O.1st read above, constituting the Telangana State Pollution Control Board (TSPCB), Hyderabad with Chief Secretary to Government as the Chairman. In the G.O.2nd read above, the Members from Local Authorities and Non-Official members were nominated. In partial modifications of the orders issued in the G.O.1st read above, Dr. Rajiv Sharma, IAS (Retd.) was appointed as part-time Chairman of the Board vide G.O.4th read above. Further, orders were also issued appointing Sri. P.Satyanarayana Reddy, IAS as Member Secretary, TSPCB vide G.O.3rd read above.

2. The Hon'ble National Green Tribunal, New Delhi in their orders 5th read above issued certain directions to all the State Governments in respect of qualifications of Chairmen and Member Secretaries of the States, which is set aside by the Hon'ble Supreme Court of India in its order 6th read above.

3. The term of 3 years of the members of the Telangana State Pollution Control Board constituted vide G.Os 1st, 2nd, 3rd and 4th read above was completed by 6.7.2017 requiring the State Government to constitute the Board Members for the next term. But keeping in view, the orders of Supreme Court of India 6th read above, Government have extended the term of the Telangana State Pollution Control Board for a further period of six months or till framing of new rules in respect of the qualifications of the Chairman and Member Secretary

4. The Member Secretary, Telangana State Pollution Control Board, Hyderabad in his letter 8th read above, has stated that the Board meeting as not conducted in the month of December, 2017 due to unavoidable circumstances and the term of the Board was expired on 5.1.2018. He has therefore, requested for reconstitution of the Board at the earliest if necessary by following earlier precedent as was done vide G.O.Ms.No.2, EFS&T (Env) Deptt., dated: 7.7.2014 to save time by appointing five official members and two representing the Companies and Corporations & Member Secretary as Member Convener in case it is felt that it will take some time to constitute full-fledged Board.
